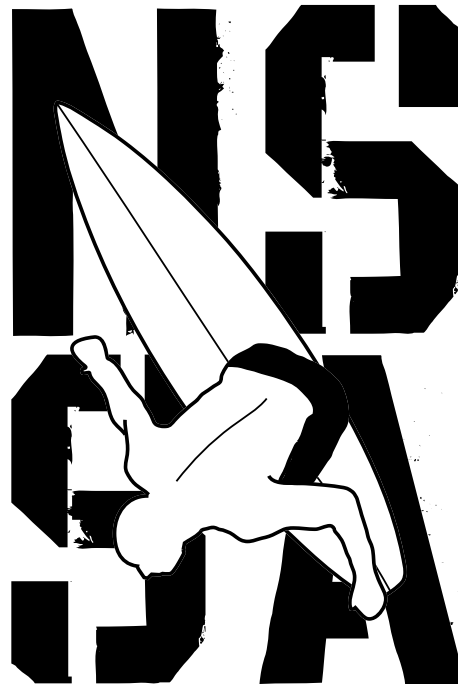

# How to compete in the NSSA Northeast Open/Explorer Season

- 1. YOU MUST PAY THE NSSA MEMBERSHIP FEE. This fee must be paid online at [nssa.org](http://nssa.org) and will cost \$80.00.**
2. Mail entry blank and fee(s) **to reach the NSSA office by 12:00 noon the Wednesday before the event** you wish to enter. **NO PHONE ENTRIES WILL BE ACCEPTED!!** If your entry form and fees do not reach the office by 12:00 noon the Wednesday before the event you wish to enter, you will have to pay the beach entry fee if you want to enter that event.
3. There are **no refunds**. Only transfers are permitted if you submit a doctors note.
4. Competitors in all divisions will receive ratings on an accumulative basis. Competitors who are prominently rated will be invited to compete in the NSSA EAST COAST CHAMPIONSHIPS and the NSSA NATIONAL CHAMPIONSHIPS. See 2010/11 rule book for NSSA East Coast/National Championship qualifications and requirements.
5. Each competitor must surf at least 3 of 6 events in order to qualify for the East Coast Championships and Nationals.
6. Each additional division entry is an extra \$30.00.
7. All competitors should check the website below number after 3:00 p.m. on the Friday before the event to get updated contest information.
8. Open/Explorer Season Academic Requirements: Open Season competitors must be full time students and maintaining a minimum 2.0 G.P.A. Explorer Season Competitors 18 and under must be a full time student maintaining a minimum 2.0 G.P.A. or show completion of High School.
9. It is the competitors responsibility to know and understand NSSA competition rules and academic requirements. The NSSA rule book is available online.
10. If you bounce a check, you will be required to pay the NSSA in cash or money order \$25.00 plus the amount of the check that bounced. If you bounce more than one check, only cash or money orders will be accepted.
11. If you can't make an event, you may pay and receive minimum points. You may only do this for single rated events.
12. Some events may have to be postponed to later dates. While we do try to avoid any conflicts with contests, sometimes it is inevitable. Especially when there is lack of surf or extreme weather conditions. Always check the NSSA website at the below address for updated contest information.

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
